East Coast Islands, the Hamptons & the Big Apple Itinerary

DAY 1: Arrive Boston Area

Depart on your flight for the Boston area (BOS or PVD) and meet your Premier World Discovery Tour Director upon arrival. Travel to the **Mohegan Sun Resort & Casino** and check-in for a 3 night stay. DAY 2: Mystic Seaport

Today visit **Mystic Seaport**, a replica of a 19th century New England fishing village. Upon arrival enjoy a **Mystic Horse Drawn Carriage Tour** to give you a relaxing overview of the village. Among its 17 acres are historic houses, shops and trade buildings that promote an understanding of life in a seaport village. Ship models, scrimshaw figureheads, boats and other relics trace the history of ships, shipbuilding and maritime activities. Later return to the resort for an included dinner.

DAY 3: Block Island, Rhode Island

This morning board a **Ferry** headed to picturesque **Block Island**. Located just 15 miles off the coast of Rhode Island, Block Island is a total of 11 square miles with 17 miles of beach and 400 miles of stone walls. Upon arrival enjoy a **Block Island Tour** to see the highlights of the island such as the majestic 200 foot high **Mohegan Bluffs** and the **North & South Lighthouses**. Later enjoy free time for a bite to eat and to explore the quaint shops in town before boarding your Ferry back to the mainland.

DAY 4: New York City Tour

Early this morning travel south to visit New York City, **the Big Apple!** Enjoy a **New York City Tour** featuring many of Manhattan's most famous attractions and areas. See **Times Square** and the **Wall Street District**. Also see famous landmarks like the **Chrysler & Empire State Buildings** and **St. Patrick's Cathedral**.

Visit the **9/11 Memorial**, a tribute of remembrance to the victims & events of September 11, 2001. Then visit the **9/11 Memorial Museum**, a moving experience located within the archaeological heart of the World Trade Center which documents the impact of the events and explores the continuing significance of September 11, 2001. Later travel to Long Island and check into your hotel for a 2 night stay.

DAY 5: The Hamptons - Sag Harbor

This morning travel to famous **Southampton** where stars such as Jerry Seinfeld and David Letterman along with Wall Street moguls have homes. See picturesque Main Street before heading through the historic district, the harbor area and along Ocean Drive, passing homes of the rich and famous. Continue to **Sag Harbor**, a picturesque and quaint town where you will have free time to enjoy lunch on your own and its unique atmosphere. Also visit the **Montauk Point Lighthouse**, authorized during George Washington's administration, completed in 1796 & part of Long Island's history for over 200 years. This evening enjoy a **Farewell Dinner** with your fellow travelers.
